This letter is written in strong support of the application of Jennifer Samimi to your scholarship program. I have known Jennifer for a couple of years now, initially as a student in my classes. She has been involved in a number of leadership programs on our campus including; Chancellor's Scholars and Leaders, Indigenous Support Network, the campus branch of Amnesty International, the American Friends Service Committee, and the campus branch of Jobs with Justice. I have served in the past on the Truman Scholarship committee, and we have had students selected for this honor. I believe that Jennifer clearly exemplifies the qualities you seek in a Truman scholar.

Jennifer is in the top 5% of students that I have had the pleasure of working with, in my twenty years as a university professor.
